**Conference call with Jaime Rudolph from Grant Thornton**

Jamie provided Council with a draft copy of the Tobacco review and Council has gone over it and approved the draft copy. Grant Thornton will revise the draft version with minimal changes to be completed in the next few days.

**Grant Thornton Year-End 2014 Audit**

Verbal warnings issued to Directors who haven't been cooperating with the auditors. A memo was issued and emailed to all directors giving a warning by Council  
These warnings will be issued and put on their personnel file.  
There is continuous a lack of supporting documents and lack of support from staff members

**Fishery**

The Director of Fishery met with Council to update and discuss the 2014 Fishing Season. This year was a very successful year in Lobster and Crab. With that being said, the director suggested having a bonus for both lobster and crab, under the conditions that ALL winterization be done by the fishermen.

The director provided council with a breakdown of their budget on each boat, how much was caught, and a percentage breakdown for their bonus. It was also recommended that because the first mate and deckhands have the same amount of bonus across the board. Council approved that recommendation.

It was recommended that 20% or 25% of their bonus be withheld until winterization is completed thus ensuring the boats are all winterized. There is also a safety program mandatory for all fishermen to attend in September, which would require 2 boats to be in the water, this would result in winterizing those 2 boats after the program. Council approved that recommendation.

With the data that was captured in this year's season they are able to see now what and where and how much is being caught. A Council member and the director will meet with the fishermen to discuss and make a plan for next year's season.

This year each vessel had their own budget. Some expenses incurred due to the breakdowns but overall this fishing season the fishermen maintained their quotas. Council suggested meeting with all fishermen to get their input and concerns. There is little to no communication between the fishermen, fishery department and Council. Director will notify the fishermen and set up a meeting in the near future.


