## **Opening Remarks**

Molly Peters and Annie Chau both work at Antigonish Women's Resource Centre. Their office is out of the Paqtnkek Health Centre. They are currently looking for a member of council to sit on the advisory board. The members will meet once or twice a month. Provide feedback and develop workshops. They are currently working on a needs assessment and partner with the Status of women association. They are hoping other communities will get involved. In the process of looking for more funding. Strength by the community and run by the community.

Health Director is meeting with other health directors at cmm and will ask to see if anyone wants to join in on the project.

Councillor Darlene Prosper and Councillor Robert Pictou both offered to sit on the advisory committee to have a representation from both sexes.

### River's Bend Proposal to Council

Paul Van de Weil owns River's bend and they are currently facing some challenges with lumber shortage. Paul brought some representatives from Quebec. Approaching Council with the option to join together on a joint venture.

River's Bend currently have a low supply of raw materials and are getting supply from Quebec and Maine. They are looking to partner with Paqtnkek to provide the raw materials for River's Bend instead of getting it from Quebec and Maine.

FP innovations is the highest not for profit research in Canada – receive funded by natural resources of Canada – job creations, they are willing to make recommendations on what equipment to use, and provide safety training on the use of proper equipment,

Mr. Van de Weil said the Band needs about 51% partnership before Paqtnkek can access the funds from Ulnooweg. He wants Paqtnkek to dry and kiln the wood before being finished.

Rivers's Bend is wondering if the band would be interested in starting this partnership. They would like to know by Christmas if Paqtnkek is really interested in joining the joint venture with rivers bend. Willing to put in the time to find other funding sources.
